# GOVERNMENT OF PUDUCHERRY (ABSTRACT)

Health - Launching of National Urban Health Mission - Reconstitution of District Committees under National Health Mission - Orders issued.

The National Rural Health Mission is implemented in the UT of Puducherry as per the guidelines of Government of India and entering into a Memorandum of Understanding with the Ministry of Health and Family Welfare, New Delhi. At the initial constitution the Mission activities centred around poor and other deprived class of people who could not reach health facilities situated in urban areas and receive quality health care through Government support. The National Rural Health Mission mainly covers Reproductive and Child Health and Family Planning activities and other Disease Control Programmes which were previously running under the directions of Government of India as Centrally Sponsored Schemes. Funding pattern has been fixed at 75:25 between Central and State Government for implementation of these health activities through National Rural Health Mission.

- 2. In the context of rapid urbanisation in India and realising the significant gap in availability of Public Health Care to urban poor and considering that 97 million people live in urban slums which figure would be increasing rapidly, Government of India has launched National Urban Health Mission, to improve the access of the urban poor to quality primary health care.
- 3. The National Urban Health Mission will cover all the cities and towns with the population of more than 50,000, all district headquarters and State capitals. Towns with a population of below 50,000 will be covered under National Rural Health Mission. While National Urban Health Mission would aim to improve the health status of the urban population in general and particularly of the poor and other disadvantaged sections by facilitating equitable access to quality health care through revamped public health system, having high focus on urban poor population living in listed and unlisted slums, vulnerable population such as homeless, ragpickers, street children, rickshaw pullers, construction, brick and lime kiln workers, sex workers and other temporary migrants, the National Rural Health Mission will continue to concentrate its activities around the rural poor and also covering Reproductive and Child Health, Family Planning and other Disease Control Programmes.
- 4. In view of launching of the National Urban Health Mission as parallel programme to National Rural Health Mission, the activities of these two national programmes have been brought under the ambit of upgraded National Health Mission. The overarching National Health Mission henceforth will be the focal centre for delivery of Health Care needs of the people in and other poor and disadvantaged sections in particular, through National Rural Health Mission and National Urban Health Mission.

- 5. The Government of Puducherry having subscribed to the National policy in providing accessible, affordable, effective, reliable health care of quality to all the citizens and in particular to the poor and vulnerable sections of the population and having entered into a Memorandum of Understanding with Ministry of Health and Family Welfare Services, New Delhi in this regard, has proposed to launch National Urban Health Mission in the UT along with the existing National Rural Health Mission under the overarching National Health Mission and to continue delivery of health care through the National Rural Health Mission and National Urban Health Mission as the two Sub Missions of National Health Mission.
- 6. Now, therefore, in supersession of G.O. Ms. No.47 dated 25.06.2010, the Lieutenant Governor of Puducherry is pleased to reconstitute the District Health Missions in Puducherry, Karaikal, Mahe and Yanam regions under National Rural Health Mission to exercise its power and functions under the revised concept of National Health Mission for identification of policy changes to be taken up with the State Health Mission, consideration and approval of plans / proposals for submission to State Health Mission, consideration and approval of proposals with delegated powers, review of progress in all Mission activities and advocacy of measures required to promote National Rural Health Mission and National Urban Health Mission and implementation / review, activity schedule of Programme Committees and follow up on action of the decision of the State Health Mission as detailed below:

The non-official members will be paid TA / DA as eligible to the officers as per NHM guidelines.
